

Region 4 Education Service Center Preschool Least Restrict Environment Project (PLRE): *Collaboration for Accelerating Skills (CAS)*

Agreement 2013-2014

Project Description:

Region 4 Education Service Center (Region 4) is pleased to provide the opportunity to school districts to participate in a project focused on programming for students with speech and language disabilities for teams including a special education teacher (PPCD), the Speech-Language Pathologist (SLP), and a general education prekindergarten and/or kindergarten teacher. This project is designed to provide teams with knowledge, skills and materials to develop appropriate and effective interventions for students with speech and language disabilities.

To participate in this project, participants must be part of a team that works with students with speech and language disabilities whose special education services are provided in the inclusive classroom by the SLP, PPCD teacher and general education teacher. Teams must be nominated by their school district, and selected by Region 4 as a participating team. The special education director/designee, campus administrator and the participants must sign the agreement. Priority will be given to school districts with a PBMAS Indicator 6 Performance Level of 3, 2 or 1.

Each team must consist of service providers that include:

- the itinerant special education teacher responsible for implementation of language IEP goals of students with speech and language disabilities in the general education prekindergarten or kindergarten classroom,
- the speech-language pathologist, and
- the general education classroom teacher (prekindergarten/kindergarten). A school district may choose to have a team of four that includes both a prekindergarten and kindergarten teacher.

Region 4 will underwrite the cost of the trainings. A substitute reimbursement of up to \$75 per training day, for those team members needing substitute teachers will be provided. All project materials will be provided to the district for use by the selected participants in their district. This project is partially funded through state and federal grants.

- Provide 4 days of training during the first year to support skill development to design research-based interventions for students with Speech Impairments

- Provide relevant homework opportunities and implementation guidelines for participants to enhance application of strategies and skills
- Provide materials to support implementation of the training
- Provide substitute reimbursement of up to \$75 per training, as needed, for selected participants
- Provide opportunities for networking

- Nominate the designated project team participants by returning this form to Region 4 by September 20, 2013
- Release the project participants to attend all of the designated professional development training, technical assistance and networking opportunities
- Provide support for the participants to engage in the homework opportunities and to implement new learning
- Provide access to the Internet and e-mail for participants to participate in online networking with other teachers and Region 4 staff members

- Attend and actively participate in all training sessions, technical assistance and networking opportunities during the project
- Complete homework opportunities and implementation plans by designated dates
- Implement research-based teaching strategies with students
- Share information obtained through the project with relevant district staff
- Participate in online networking with other teachers and Region 4 staff members
